A Bill for an Act to amend the 2013 Appropriation Act to authorise the issue from the Consolidated Revenue Fund of the Federation the total sum of **=N=4,987,220,425,601** (Four Trillion, Nine Hundred and Eighty Seven Billion, Two Hundred and Twenty-Two Million, Four Hundred and Twenty-Five Thousand, Six Hundred and One Naira) only, of which, **=N=388,053,200,000** (Three Hundred and Eighty-Eight Billion, Fifty Three Million, Two Hundred Thousand Naira) Only is for Statutory Transfers, **=N=591,764,000,000** (Five Hundred and Ninety-One Billion, Seven Hundred and Sixty-Four Million Naira) Only is for Debt Service, **=N=2,415,745,972,812** (Two Trillion, Four Hundred and Fifteen Billion, Seven Hundred and Forty-Five Million, Nine Hundred and Seven-Two Thousand, Eight Hundred and Twelve Naira) Only, is for Recurrent (Non-Debt) Expenditure, while the balance of **=N=1,591,657,252,789** (One Trillion, Five Hundred and Ninety-One Billion, Six Hundred and Fifty-Seven Million, Two Hundred and Fifty-Two Thousand, Seven Hundred and Eighty-Nine Naira) Only is for contribution to the Development Fund for Capital Expenditure for the year ending 31st December, 2013.

BE IT ENACTED by the National Assembly of the Federal Republic of Nigeria as follows: -

(i) The Accountant-General of the Federation shall, when authorised to do so by Warrants signed by the Minister charged with responsibility for finance, pay out of the Consolidated Revenue Fund of the Federation during the year ending on the 31st day of December 2013, the sums specified by the warrants, not exceeding in the aggregate **=N=4,987,220,425,601** (Four Trillion, Nine Hundred and Eighty Six Billion, Two Hundred and Two Million, Four Hundred and Twenty-Five Thousand, Six Hundred and One Naira) only,.

Issue and appropriation of **=N=4,987,220,425,601** from the Consolidated Revenue Fund for 2013

(ii) The amount mentioned in subsection (i) of this section is hereby appropriated to the heads of expenditure as specified in the Schedule to this Act.

(iii) No part of the amount aforesaid shall be released from the Consolidated Revenue Fund of the Federation after the end of the year mentioned in subsection (i) of this section.

Amounts appropriated under this Act shall be released from the Consolidated Revenue Fund of the Federation and applied only for the purpose specified in the Schedule to this Bill.

This Bill seeks to amend the 2013 Appropriation Act to authorise the issue from the Consolidated Revenue Fund of the Federation the total sum of **=N=4,987,220,425,601** (Four Trillion, Nine Hundred and Eighty Seven Billion, Two Hundred and Twenty-Two Million, Four Hundred and Twenty-Five Thousand, Six Hundred and One Naira) only, of which, **=N=388,053,200,000** (Three Hundred and Eighty-Eight Billion, Fifty Three Million, Two Hundred Thousand Naira) Only is for Statutory Transfers, **=N=591,764,000,000** (Five Hundred and Ninety-One Billion, Seven Hundred and Sixty-Four Million Naira) Only is for Debt Service, **=N=2,415,745,972,812** (Two Trillion, Four Hundred and Fifteen Billion, Seven Hundred and Forty-Five Million, Nine Hundred and Seven-Two Thousand, Eight Hundred and Twelve Naira) Only, is for Recurrent (Non-Debt) Expenditure, while the balance of **=N=1,591,657,252,789** (One Trillion, Five Hundred and Ninety-One Billion, Six Hundred and Fifty-Seven Million, Two Hundred and Fifty-Two Thousand, Seven Hundred and Eighty-Nine Naira) Only is for contribution to the Development Fund for Capital Expenditure for the year ending 31st December, 2013.
