A Bill for an Act to authorise the issue from the Consolidated Revenue Fund of the Federation the total sum of =N=4,642,960,000,000 (Four Trillion, Six Hundred and Forty-Two Billion, Nine Hundred and Sixty Million Naira) only, of which, =N=399,687,801,891 (Three Hundred and Ninety-Nine Billion, Six Hundred and Eighty-Seven Million, Eight Hundred and One Thousand, Eight Hundred and Ninety-One Naira) Only is for Statutory Transfers, =N=712,000,000,000 (Seven Hundred and Twelve Billion Naira) Only is for Debt Service, =N=2,430,665,361,597 (Two Trillion, Four Hundred and Thirty Billion, Six Hundred and Sixty-Five Million, Three Hundred and Sixty-One Thousand, Five Hundred and Ninety-Seven Naira) Only, is for Recurrent (Non-Debt) Expenditure while the balance of =N=1,100,606,836,512 (One Trillion, One Hundred Billion, Six Hundred and Six Million, Eight Hundred and Thirty-Six Thousand, Five Hundred and Twelve Naira) Only, is for contribution to the Development Fund for Capital Expenditure for the year ending on the 31st day of December, 2014.

BE IT ENACTED by the National Assembly of the Federal Republic of Nigeria as follows: -

(i) The Accountant-General of the Federation shall, when authorised to do so by Warrants signed by the Minister charged with responsibility for finance, pay out of the Consolidated Revenue Fund of the Federation during the year ending on the 31st day of December 2014, the sums specified by the warrants, not exceeding in the aggregate =N=4,642,960,000,000 (Four Trillion, Six Hundred and Forty-Two Billion, Nine Hundred and Sixty Million Naira) only.

Issue and appropriation of =N=4,642,960,000,000 from the Consolidated Revenue Fund for 2014

- (ii) The amount mentioned in subsection (1) of this section shall be appropriated to heads of expenditure as indicated in the Schedule to this Act.
- (iii) No part of the amount aforesaid shall be released from the Consolidated Revenue Fund of the Federation after the end of the year mentioned in subsection (1) of this section.
- All amounts appropriated under this Act shall be released from the Consolidated Revenue Fund of the Federation only for the purpose specified in the Schedule to this Act.

Release of funds from the Consolidated Revenue Fund

In the event that the implementation of any of the projects intended to be undertaken under this Act cannot be completed without virement, such virement shall only be effected with the prior approval of the National Assembly.

Virement

For the purposes of this Act the term "schedule" includes the detailed estimates of expenditure attached thereto

Interpretation

5 This Act may be cited as the Appropriation Act 2014.
